MOUNTAIN LION

Recent mountain lion activities in the The Retreat remind us that we all need to be aware of our surroundings. Lions are most active dusk to dawn but will travel and hunt in daylight. The Retreat is prime Mountain Lion habitat: ponderosa pine, juniper and brush with an abundance of deer.

Take precautions. Make lots of noise when you are outside during dawn to dusk hours. Have outside lights that can be turned on when you go outside at night. Supervise children closely when they are playing outside. Remove vegetation around your house where a lion might be able to hide. Fowler at giniwot@aol.com or Plant native shrubs and plants. Deer often prefer to eat non-native plants. Using non-native varieties encourages deer to come onto your

Introducing the RLA Good Neighbor Committee



Noxious Weed Invasion

Noxious weeds are non-native plants that have been brought into the United States, mostly by accident. These plants disrupt the natural ecology and are harmful and undesirable.

The noxious weeds take over important wildlife habitat and devastate the diversity and quality of native plants. Many noxious weeds do not hold and protect the soil, as native plants do. Noxious weeds can actually cause an increase in soil erosion.

Invasive non-native plants cause millions of dollars of damage to agriculture, recreational and tourism industries in the West. Some of these plants are toxic and cause injury to wildlife and livestock.

Noxious non-native weeds have no natural enemies in the U.S. They grow rapidly and reproduce in many types of growing conditions. These types of plants produce thousands of seeds and have extensive root systems that allow them to quickly take over an area and go on to dominate an entire landscape.

Weeds that are currently being regulated by Larimer County are Leafy Spurge, Musk Thistle, Canada Thistle, Diffuse Knapweed, Russian Knapweed, Spotted Knapweed, Dalmation Toadflax and Yellow Toadflax. Larimer County may fine homeowners or organizations not managing areas of noxious weeds.

Many of the noxious plants will be coming up in early spring. Inspect your land on a routine basis so that these weeds can be eliminated as soon as they are found.

Road Report

The pole barn is on track to be completed by the May 7 open house. Road resurfacing plans are on hold because of some recent big-ticket expenses including the new grader, the pole barn construction and emergency repairs to the pickup (snow plow). In addition, the old grader has not sold yet. The Retreat board's policy has been to maintain a cash reserve. Routine maintenance will continue. For example, gravel recently was put along Solitude Court to help stabilize several large mud holes. This summer the Retreat plans to replace the reflector poles along the roads with treated wooden posts and reflectors, if the budget allows.

Weed Control

WATER WELL DRILLING

CLEANUP

Once your well is drilled and the casing installed, please clean up the drill cuttings. The drilling contractor you hired should not allow the cuttings to flow into Retreat ditches, filling them up. If this does occur, the Retreat looks to the landowner to remove these cuttings and put the ditch back into a condition that meets the approval of the Retreat road committee. Cleanup should be completed within 10 days from the time the drilling rig leaves your property. You may not realize that an eight inch diameter hole generates about 0.35 cubic feet of material per foot of hole depth. One hundred feet of borehole would create 35 cubic feet of cuttings. These cuttings can weigh more than 120 pounds per cubic foot when dry. If these cuttings are allowed to dry they can resemble concrete and can be very difficult to remove. Failure by the landowner to remove these cuttings within ten days may result in the Retreat doing the work with its equipment and personnel and the member being billed at the current rates. Several ditches have been clogged recently as a result of well drilling. With spring rains approaching, it is imperative to remove the cuttings from the ditches now. Senate Bill 100

On June 6, 2005, Governor Owens signed SB 100 into law. Applicable to all homeowner associations in Colorado, this law will affect all aspects of the governance and operation of associations.

The board commissioned the SB100 committee in July to retain legal counsel to develop the set of seven required documents.

SB 100 is a complex and technical bill, and the Board will be working diligently for the upcoming months to ensure our association is in compliance. As always, we will be keeping you aware of all changes to the association's policies and procedures as they become available. Parking



It is essential that the roads are accessible to the snow plow, grader, and fire department equipment. For your safety and that of your neighbors, do not park on the roads. Guest's vehicles are the only ones that may be parked temporarily along the road right-of-way.

A bear entered a house while the owner was in an adjacent garage. The owner waited for the bear to leave of its own accord. The bear was able to operate the door knobs that had levers.

Please take appropriate precautions. Keep your doors closed even while you are home. Closed screen doors are not strong enough. Close the glass on accessible windows when you are gone. Use care when entering the house if you see evidence of a break-in when returning home - the bear may still be there.

A bobcat was sighted in the upper section of Dunraven. It's a very big gray cat, not as large a as



Recipe

Here's a soup recipe that we enjoy!

I pound hot Italian sausage, browned and drained (Boulder sausage is a good brand)

I large onion, chopped

3 cloves of garlic

3 cans of chicken broth

28 oz. purec tomatoes

8 oz. can tomato sauce

I cup dry red wine

2 carrots, chopped

1 Tablespoon sugar

2 teaspoons Italian seasoning

2 small zuechini, chopped

Parmesan cheese

Simmer all the ingredients, except the zucchini, for 30 minutes. Then add the chopped zucchini and simmer another 10 minutes or until done. Serve with a little shredded Parmesan cheese on top. I usually double the recipe and use a Dutch oven or medium stockpot.
